PLAINTIFF'S APPLICATION FOR WRIT OF SEQUESTRATION OF 2021 TOYOTA TACOMA

TO THE HONORABLE JUDGE OF SAID COURT:

NOW COMES Plaintiff, **TRAVELERS INSURANCE COMPANY**, filing this Application for Writ of Sequestration against the Defendant, HAIL SPECIALISTS AUTO BODY & COLLISION, for possession of personal property of a 2021 Toyota Tacoma located in Travis County, Texas, and in support would show:

A. DISCOVERY CONTROL PLAN

I. Plaintiff intends that discovery be conducted under Discovery Level I.

B. PARTIES

- Plaintiff, TRAVELERS INSUANCE COMPANY (hereinafter "TRAVELERS"), is a
 duly incorporated insurance company authorized to do business in and doing business in
 the state of Texas.
- 3. Defendant, HAIL SPECIALISTS AUTO BODY & COLLISION (hereinafter "HAIL SPECIALISTS"), is a duly incorporated auto repair company authorized to do business in and doing business in the state of Texas. Service of process may be made on its registered agent: Michael Chanata, CFO Hail Specialists, I0611 N. Interstate 35 Frontage Road, Austin, Texas, 78753. Issuance of process and citation is requested at this time.

C. JURISDICTION AND VENUE

- 4. Venue is proper in Travis County, Texas, pursuant to the Texas Civil Practice & Remedies Code Defendant is located in Travis County and the transactions giving rise to the claims occurred in Travis County. Jurisdiction is proper because the Court has personal jurisdiction over all parties and the amount in controversy is within the jurisdictional limits of the Court.
- 5. Plaintiff has been damaged in a sum within the jurisdictional limits of this Court and pursuant to Rule 47 of the Texas Rules of Civil Procedure, Plaintiff seeks monetary relief under \$100,000.

D. PROPERTY DESCRIPTION

6. The Defendant, HAIL SPECIALISTS AUTO BODY & COLLISION, is in possession of personal property located in Travis County, Texas, specifically described as follows:

2021 Toyota Tacoma 4WD, Color Black, VIN#: 3TMGZ5ANXMM405667

- 7. The amount in controversy in this action is \$14,050 in storage fees.
- 8. The personal property at issue in this action has a market value of \$46,148.63. Plaintiff is the owner of this personal property and is entitled to its possession.
- 9. Plaintiff is informed and believes, and on that basis alleges, that unless the court promptly issues a writ of sequestration, the defendant will conceal or dispose of the subject truck.
- 10. Plaintiff's information and belief is based on the supporting Affidavit of Trey Mathews that is attached and incorporated by reference.

E. FACTS OF CLAIM

II. Defendant is holding the Plaintiff's vehicle hostage trying to collect excessive storage fees before releasing the vehicle.

- 12. After a traffic collision on August 2, 2023, the Defendant HAIL SPECIALIST obtained possession of the subject vehicle that was owned with a finance agreement by Plaintiff TRAVELERS' insured Kevin Gates at that time. No repairs were performed on the subject vehicle.
- 13. On August 25, 2023 the Plaintiff, TRAVELERS' agent Copart, Inc. attempted to make arrangements to pick up the subject vehicle from the Defendant HAIL SPECIALISTS, but was notified that the vehicle would not be released until payment was made to Defendant HAIL SPECIALIST in the amount of \$14,050 calculated by adding Gate Charges \$300.00; Storage 08/17/2023 To 08/28/2023 @\$500.00/Day totaling \$6,000.00; Estimating Fees \$2,950.00; and Misc Fees \$4,800.00. Plaintiff TRAVELERS refused to pay the excessive storage fees and brings this action.
- 14. On August 29, 2023, The Plaintiff TRAVELERS purchased the subject vehicle from the lien holder (Exhibit A) to obtain legal ownership and currently owns the subject vehicle.

F. LEGAL AUTHORITIES & ARGUMENTS

15. The Texas Civil Practice & Remedies Code 62.001 states:

A writ of sequestration is available to a plaintiff in a suit if:

(1) the suit is for title or possession of personal property or fixtures or for foreclosure or enforcement of a mortgage, lien, or security interest on personal property or fixtures and a reasonable conclusion may be drawn that there is immediate danger that the defendant or the party in possession of the property will conceal, dispose of, ill-treat, waste, or destroy the property or remove it from the county during the suit; . . .

Acts 1985, 69th Leg., ch. 959, Sec. 1, eff. 9/1/1985.

16. Plaintiff TRAVELERS requests the Court to issue a writ of sequestration because there is

a reasonable conclusion that may be drawn that there is immediate danger that the Defendant will conceal or dispose of the property.

G. PRAYER

WHEREFORE, PREMISES CONSIDERED, Plaintiff, TRAVELERS prays that the Court will issue a Writ of Sequestration for the subject vehicle and set a hearing within I0 days to determine the issues with judgment to be entered for the Plaintiff against Defendant, HAIL SPECIALISTS, and for Court costs and for such other and further relief as the Court deems equitable.


